

Nordson Corporation fully supports the efforts of the European Union to protect people from harmful substances. Nordson's Product Compliance Department oversees quality management systems and compliance at the highest level and our Product Compliance Council consists of representatives from each Nordson business unit as well as applicable corporate functions tasked with managing the program. The Nordson team is also working with our entire supply chain to ensure compliance from our suppliers, and to ensure continued compliance within each of our businesses. The Nordson Restricted Substance List currently includes substances listed in Directive 2011/65/EU and Amendment 2015/863/EU on the restriction of the use of certain hazardous substances in electrical and electronic equipment (RoHS 2), Regulation EC 1907/2007 on the Registration, Evaluation, Authorization and Restriction of Chemicals (a.k.a. REACH), specifically the 211 substances of very high concern (SVHC) and proposed SVHC.

As of the issue date of this letter, in accordance with the European Chemicals Agency SCIP database guidelines, for all Nordson Adhesives products manufactured in the U.S. facilities and sold into the EU where we know the part contains SVHCs above the 0.1% (w/w) limit, we are in the process of including these items in the database in "quasi-identical" groups. Currently, we have entered information for the following articles:
